Progressive Tennis is the best way for kids and adults to learn how to play tennis!

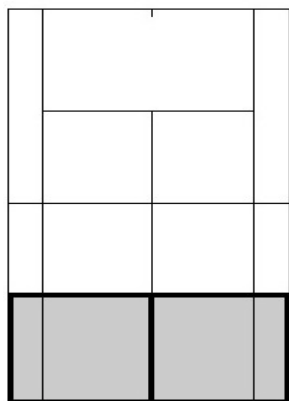
Players advance through the 4 steps using *different tennis balls* and *different court sizes*.

Step 1:  $\frac{1}{2}$  Court



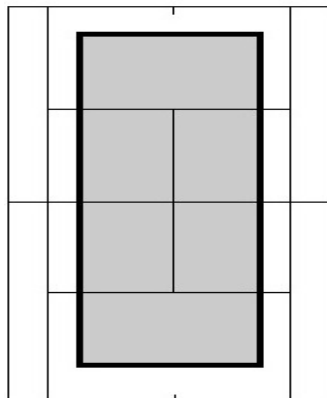
"Red Ball"



Step 2:  $\frac{3}{4}$  Court



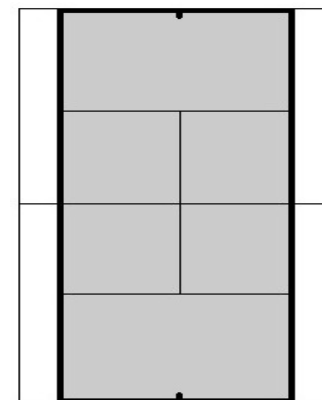
"Orange Ball"
